## Article 6 - Purpose

The corporation is organized for the following purpose or purposes:

- (a) Specifically and primarily to provide an organization consisting of the wner of a residential townhome regime to provide for the management, aintenance, preservation and architectural control of the townhome project ocated in Harris County, Texas and more particularly described in the Declaration recorded in the Office of the County Clerk of Harris County, Texas.
- (b) Generally:
- (i) To promote the welfare of the owners of the Association.
- (ii) To exercise all of the powers and privileges and to perform all of the duties and obligations of the Board of Directors as set forth in the Declaration and Bylaws.
- (iii) To fix, levy, collect, and enforce payment of any charges or assessments as set forth in the Declaration governing the community and to pay all expenses in connection with such charges or assessments, all office expenses and all other expenses incidental to the conduct of the business of the Association, including all licenses, taxes, or governmental charges levied or imposed against the property of the Association.
- (iv) To acquire (by gift, purchase, or otherwise), own, hold, improved, build, operate, maintain, convey, sell, lease, transfer, dedicate for public use, or otherwise dispose of real or personal property in connection with the affairs of the Association.
- (v) To borrow money, mortgage, pledge, deed in trust, or hypothecate any or all of the Association's real or personal property as security for money borrowed or debts incurred.
- ) To have and to exercise any and all powers, rights, and privileges that a rporation organized under the Texas Non-Profit corporation Act by law may now at a later time have or exercise.
- (vii) To act in the capacity of principal, agent, joint venturer, partner or otherwise.
- (c) Notwithstanding any of the above statements or purposes, the Association shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the primary purposes of the Association.
