### POLICY REGARDING USE OF RECREATION AREA BY LITTLE LEAGUE TEAMS

It shall be the policy of the Clear Creek Forest Section 13 Property Owners Association that the ball field located within the recreation area is held for the use of Clear Creek Forest Section 13 residents and the neighboring communities. *Clear Creek Forest Section 13 residents will be given priority until March 1st. After that, neighbors in the surrounding communities may apply on a first come first serve basis.* Those without permission shall be considered trespassers and shall be subject to legal action.

All league teams wishing to reserve a ball field for practices must comply with the following guidelines:

- 1. The team must complete all paperwork in the reservation package and return it to the CCF 13 POA Board of Trustees **and have it approved** before a reservation will be considered.
  - a. The package will contain the following:
    - i. Team Roster
    - ii. Release of Liability Form
    - iii. Park Rules & CCF 13Policy
- 2. Field preference will be given on a first come, first serve basis.
- 3. All team coaches, players and guests must abide by all park rules.
- 4. CCF 13 Board of Trustees reserves the right to revoke permission to use the recreation area at any time for violations of this policy and/or park rules.

### RELEASE FROM LIABILITY

- **11.** No restroom facility available
- **12.** CCF 13 Board of Trustees retains the right to revoke park use at any time for violations of this policy and/or park rules.
